Pursuant to OAR 860-001-0420, the Oregon Citizens Utility Board (CUB) requests that the Administrative Law Judge (ALJ) grant its motion for a Ruling modifying the schedule in the present docket as set forth below. On March 21, 2024, the Commission held a prehearing conference in this docket. At the prehearing conference, the parties agreed to the procedural schedule adopted by ALJ Mapes on April 1, 2024. At the prehearing conference, the parties also acknowledged this schedule could be revisited given that the deadline to file the Opening Brief in this docket is set for October 25, 2024, one day after the Closing Brief is due in the PacifiCorp general rate case (UE 433).

In accordance with the requirements of OAR 860-001-0420(3) and OAR 860-001-0420(7), CUB conferred with the parties in this docket and proposed moving the deadline for the Opening Brief in this docket to October 28, 2024. Public Utility Commission Staff, ChargePoint, Walmart, Verde, Fred Meyer/Kroger, and Calpine Solutions did not object to October 28th. Portland General Electric (PGE) stated that if the Closing Brief deadline in this proceeding is moved to November 8th, PGE would not object to an October 28th deadline for the Opening Briefs. AWEC noted it has other filings due on October 28th; AWEC instead proposed an October 29th deadline for Opening Briefs and a November 8th deadline for Closing Briefs.

CUB understands AWEC's opposition to an October 28th deadline and request for a deadline of October 29th instead. CUB acknowledges, however, that PGE, Staff, and NewSun proposed additional changes to the procedural schedule if the date were moved to the 29th instead of the 28th. Accordingly, while CUB would not oppose AWEC's proposal, CUB has requested the 28th for simplicity. CUB takes no position on the remaining schedule.

CUB requests that the ALJ extend the Schedule for the following event:
