On October 8, 2024, ChargePoint, Inc. (ChargePoint) filed an Unopposed Motion to Adopt Testimony and Admit Testimony by Stipulation. That prior motion requested that the Oregon Public Utility Commission (Commission): 1) allow Mr. Justin Wilson to adopt the Opening Testimony of Ms. Mal Skowron (ChargePoint/100) and 2) allow Mr. Wilson to be excused from attending the hearing and admit his adopted testimony, ChargePoint/100, into the record of this proceeding by stipulation. However, that prior motion did not include a declaration from Mr. Wilson and did not refer to Ms. Skowron’s exhibit, ChargePoint/101.
