The Fair Rate Coalition moves for an order allowing testimony and exhibits sponsored by Doug Pegar and Steve Sanders, FRC witnesses who timely filed pre-filed testimony in Phase I of this proceeding, to be accepted into the record. No party sought to cross-examine either witness.
