STAFF'S UNOPPOSED MOTION TO AMEND
SCHEDULE (PHASE II)

9 Comes now the staff of the Public Utility Commission of Oregon and asks the
10 Administrative Law Judge for a Ruling adopting the following modification to the schedule for
11 Phase II of this case:

12 Extend the date for the parties to file their simultaneous direct testimony from
13 February 20th, 2006, until February 27th, 2006.

14 The dates for the two other scheduled events (reply testimony and the hearing) would remain as
15 now set.

16 The reasons for this is request are: (1) the current due date for the parties' simultaneous
17 direct testimony, February 20, 2006, falls on a federal holiday; and (2) the hearing in the Phase I
18 Compliance investigation is February 2nd, so the proposed date would allow the parties more
19 time to prepare their Phase II direct testimony.
