Pursuant to OAR 860-001-0090(h), 860-001-0420(1), 860-001-0420 (7) Portland General Electric Company (“PGE”) hereby submits this motion for a two-day extension of the deadline to file Opening Testimony for all parties in this docket. Opening Testimony is currently due on Wednesday, November 14, 2012. Because of conflicting demands in other proceedings, PGE requests a brief extension of time until Friday, November 16, 2012, for all parties to file Opening Testimony. Under the current schedule in this docket, Reply Testimony is due on January 14, 2013. Accordingly, the requested two-day delay will not impact the remainder of the schedule in this proceeding.

PGE has consulted with the active participants or their counsel in this docket (Commission Staff, PacifiCorp, Idaho Power Company, Industrial Customers of Northwest Utilities, Citizens' Utility Board of Oregon, and Northwest and Intermountain Power Producers Coalition) and each has represented that it has no objection to this motion.

For the reasons stated above, PGE requests that the administrative law judge issue a ruling extending the deadline for parties to file Opening Testimony until November 16.

Because Opening Testimony is due on November 14, expedited consideration of this motion is requested.


