Dear Judge Kirkpatrick:

We write to request that the parties in the above-referenced dockets (the "Dockets") be given an opportunity to submit a single round of simultaneous briefs to address the impact of Order No. 06-379 (UE 170) on the Complaint and Deferred Accounting Application in the Dockets.

Portland General Electric Company's ("PGE") motion to dismiss the Complaint and comments requesting denial of the Deferred Accounting Application are pending in the Dockets. The Joint Ruling deferred action in the Dockets given that the Complaint and Deferred Accounting Application were based on Order No. 05-150 and the Commission had at that time granted PacifiCorp's reconsideration request of Order No. 05-150. On July 10, 2006, the Commission issued a final order on reconsideration, Order No. 06-379.

Given that the Dockets have been held in abeyance pending issuance of the reconsideration order, PGE submits that a single round of briefing regarding the reconsideration order's impact in these Dockets will be helpful to the Commission, will not unduly delay the dockets, and will cause no party prejudice. We request that the briefs be due sometime in late August. Thank you for your consideration of this request.
