
MOTION TO ADMIT STAFF TESTIMONY

AFFIDAVIT OF MAURY GALBRAITH

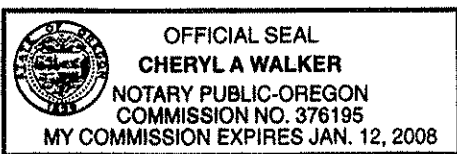
I, Maury Galbraith, hereby depose and say:


1. I am employed by the Public Utility Commission of Oregon (“the Commission”) as the senior economic analyst in the Electric and Natural Gas Division.
