

Request for Extension of Deadline for Submittal of Cross-examination Statements

On December 21, 2009, a Memorandum was issued in this docket requiring the parties to submit, by January 4, 2010, a statement regarding the witnesses they intend to cross-examine at the hearing scheduled for January 14, 2010. The parties had previously scheduled a settlement conference for the afternoon of January 4, 2010. That settlement conference may impact the scope of or need for cross-examination of witnesses. Accordingly Portland General Electric ("PGE") requests that the deadline for submitting cross-examination statements be extended to January 6, 2010.

The Industrial Customers of Northwest Utilities support this request. PGE also tried to contact Staff and the Citizens' Utility Board about this request, but was unsuccessful.
