MOTION TO AMEND THE SCHEDULE

The Oregon Cable Telecommunications Association (“OCTA”) hereby submits this Motion to Amend the Schedule and Request for Expedited Consideration in the above-captioned matter. In support of this motion, OCTA states as follows:

Pursuant to the procedural schedule issued in this docket on September 24, 2012, pre-filed opening testimony of Commission Staff and all parties is currently due on November 16, 2012. In order to allow additional time for discovery prior to the filing of opening testimony, OCTA moves the Commission for an Order modifying the procedural schedule to extend the deadline for filing of opening testimony of Staff and all other parties to November 26, 2012. No other changes to the procedural schedule are requested. With the proposed change to the opening testimony deadline, there will still be approximately seven (7) weeks between the opening and reply testimony deadlines.

No parties to the proceeding will be prejudiced by the proposed modification to the procedural schedule. OCTA has contacted Commission Staff and all other parties to the docket. No parties object to the request for an extension of the opening testimony deadline. Because no parties object, OCTA requests expedited consideration of this Motion.


CONCLUSION
