**JOINT UNOPPOSED MOTION TO AMEND THE SCHEDULE**

The Oregon Cable Telecommunications Association (“OCTA”), the Oregon Telecommunications Association (“OTA”), Frontier Communications of Oregon (“Frontier”), and Qwest Corporation d/b/a CenturyLink QC (“CenturyLink”) hereby submits this Joint Unopposed Motion to Amend the Schedule. In support of this Motion, OCTA, OTA, Frontier and CenturyLink state as follows:

OCTA, OTA, Frontier, and CenturyLink have been in active settlement discussions in this proceeding and have made substantial progress. 


