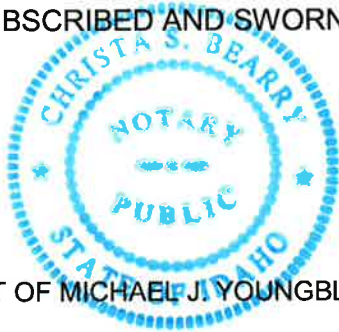
I, Michael J. Youngblood, being first duly sworn on oath, depose and say:
