PacifiCorp d/b/a/ Pacific Power (Pacific Power or Company) respectfully requests that the Public Utility Commission of Oregon (the “Commission”) issue an order modifying the procedural schedule in this docket. PacifiCorp, Public Utility Commission of Oregon staff, and stakeholders have been engaged in settlement discussions, and are close to reaching agreement on the terms of a settlement stipulation. PacifiCorp proposes the following revisions to the procedural schedule:
