Aspen Lakes Utility Company (“Aspen Lakes”) moves for a 60-day extension to file its General Rate Revision as required by the Stipulation of the parties adopted by the Commission in Order No. 20-108. This is the Aspen Lakes’ Second request for an extension. The first request was filed June 30, 2021, with a due date of August 31, 2021. The new due date would be November 1, 2021.

Aspen Lakes has conferred with counsel for Staff and Intervener Aspen Lakes Estates Owners, Inc. Staff does not oppose Aspen Lake’s request based on the understanding that this is the final request for an extension. Intervener Aspen Lakes Estates Owners, Inc., does object.

Pursuant to the Stipulation, Aspen Lakes Utility Company is to make a General Rate Revision filing with a test year reflective of the 2020 no later than June 30, 2021.

Aspen Lakes is diligently working on its filing but has had difficulty obtaining third-party insurance quotations to complete the filing. Aspen Lakes resources were also diverted in July and August 2021 to efforts to repair its irrigation pumping system, which were successfully completed on August 25, 2021.
