8 system will be sold to Medford to supply electric power for Medford's water treatment  
9 operations.

10 5. Medford's participation in these proceedings will be in the public interest and will not  
11 unreasonably broaden the issues, burden the record or delay the proceeding.

12 Medford requests the Commission to grant this petition to intervene with full party status  
13 in this proceeding.
