


3 3. Portland General Electric Company (“PGE”) filed its Integrated Resource Plan  
4 with the Commission on November 5, 2009, pursuant to Commission Order No. 08-246 in  
5 Docket No. LC 43, and Commission Order No. 07-002 in Docket No. UM 1056. As an electric  
6 public utility which develops its own integrated resource plan and is subject to the jurisdiction of  
7 the Commission, Pacific Power has an interest in this proceeding, including any  
8 acknowledgement conditions proposed by the parties or the Commission.

9 4. No other party can adequately represent the interests of Pacific Power in this  
10 proceeding.

11 5. Pacific Power intends to fully cooperate in this proceeding and will not  
12 unreasonably broaden the issues, burden the record, or unreasonably delay the proceeding.

14 petition to intervene.
