**PETITIONS FOR

1. Pursuant to ORS 756.525 and OAR 860-001-0300, Move Idaho Power (MIP) and Nancy Peyron petition to intervene in this docket.
2. Nancy Peyron is a resident of Baker County who owns property near one or more of the transmission line routes proposed by Idaho Power Company (IPC). Her property and environment will be affected by the construction and operation of the line. Her address is:

3. MIP is an Oregon nonprofit corporation dedicated to preventing the construction of new transmission lines through historically or environmentally sensitive areas in Baker County, Oregon. MIP's contact information is the same as that of Nancy Peyron. MIP has 120 participants. MIP is represented in this proceeding by attorney Milo Pope (address information provided at the bottom of this Petition).
4. Petitioners intend to pursue in particular issues pertaining to the need for and

routing of proposed transmission lines. The need for transmission lines is related to the need for power and/or conservation in general. Petitioners seek full party status so that all issues can be addressed.

5. Petitioners do not agree to receive electronic service of voluminous filings. Petitioners request physical service of all documents filed by Idaho Power Company, because those documents are likely to contain colored charts and maps that Petitioners cannot reliably or economically produce from electronic files.
6. Petitioners request the granting of their interventions in this docket and the placing on the service list of Nancy Peyron, Daniel Meek, and Milo Pope, at the street addresses and email addresses provided above and below. Their participation will not unreasonably broaden the issues, burden the record, or delay the proceedings.
