#### NATURE AND EXTENT OF THE PETITIONER'S INTEREST IN THE PROCEEDING:

Under ORS 468.035(c) and (f), the Oregon Department of Environmental Quality ("DEQ") is statutorily charged with advising, consulting and cooperating with other state agencies regarding "any proceedings and all matters pertaining to control of air ... pollution" and with providing "advisory technical consultation and services . .. to state agencies." And under ORS 468.045(1)(d), the DEQ Director is "authorized to participate in any proceeding before any public officer, commission or body of ... any state for the purposes of representing the citizens of Oregon concerning environmental quality." The U.S. Environmental Protection Agency has proposed new rules pursuant to Clean Air Act section 111(d) to reduce greenhouse gas emissions from existing power plants and DEQ will be the lead state agency in Oregon responsible for complying with such rules. As proposed, the rule contemplates that some compliance actions may involve actions by electric utilities, such as PacifiCorp, that are also subject to the jurisdiction of the Public Utility Commission. DEQ's interest in this docket is in coordinating its air quality responsibilities closely with the responsibilities of the PUC and PacifiCorp in the development of PacifiCorp's integrated resource plan.
