Renewable Northwest is a non-profit advocacy organization that works to decarbonize the region by accelerating the transition to renewable electricity. Renewable Northwest has approximately 75 member organizations that include renewable energy developers and manufacturers, as well as consumer advocates, environmental groups, and other industry advisers. The common goal of Renewable Northwest's members is for every home, business, and vehicle in the Northwest to be powered by renewable, affordable, carbon-free electricity.

4. The nature and extent of the Petitioner's interest in the proceeding is:

In pursuit of our mission to decarbonize the Northwest, we actively participate in proceedings and discussions related to utility resource planning and procurement processes. Renewable Northwest has been an active stakeholder in PGE's 2019 and PacifiCorp's and Idaho Power's 2021 Integrated Resource Plans, as well as PacifiCorp's 2020 and 2022 All-Source Request for Proposals (Docket Nos. UM 2059 and UM 2193), PGE's 2021 All-Source Request for Proposals (Docket No. UM 2166), and utility regulatory processes in other states. We have worked on the implementation of Oregon's 100% clean electricity law, HB 2021 (2021), including in Dockets UM 2225 and UM 2273. Accordingly, no other party can adequately represent Renewable Northwest's interest in this proceeding.

5. The issues the Petitioner intends to raise at the proceeding are:

Renewable Northwest intends to participate as a party and raise issues that are appropriate to the proceeding.

6. The special knowledge or expertise of the Petitioner that would assist the Commission in resolving the issues in the proceeding is:

Renewable Northwest has a long history of participating in discussions and regulatory proceedings related to utility resource planning and procurement to support fair and robust resource decisions, as discussed above.
