4. The nature and extent of the Petitioner's interest in the proceeding is:

In pursuit of our mission to decarbonize the Northwest, we actively participate in proceedings and discussions related to utility resource planning and procurement processes. Renewable Northwest has been an active stakeholder in the regulatory processes addressing PGE's 2023 Integrated Resource Plan and Clean Energy Plan, PacifiCorp's 2021 and 2023 IRPs and CEP, and Idaho Power's 2021 IRP, as well as PacifiCorp's 2020 and 2022 All-Source Request for Proposals, PGE's 2021 and 2023 All-Source RFP, Idaho Power's 2026 All-Source RFP, and utility regulatory processes in other states.
