USCC is interested in the issues raised in this proceeding. USCC is an Eligible Telecommunications Carrier (“ETC”) that receives federal universal service support in the state of Oregon. Disaggregation of federal universal service support received by rural incumbent local exchange carriers will likely impact the federal universal service support that USCC will receive. 
