Pursuant to ORS § 756.525 and OAR § 860-012-0001, Biomass One, L.P., a Delaware limited liability company (“Biomass One”) hereby petitions the Oregon Public Utility Commission (“Commission”) to intervene in this proceeding with full party status as described in OAR § 860-011-0035(5). In support of this petition, Biomass One represents as follows:

3. Biomass One is limited partnership with offices in White City, Oregon. Biomass One owns and operates a 25 MW qualifying facility in White City and is a party to a

long term Power Sales Agreement with PacifiCorp. The Power Sales Agreement expires in 2011.

4. Biomass One has a substantial interest in the Commission's investigation to determine if PacifiCorp's rate revision has been consistent with the methodologies and calculations required by Order No. 05-584, and because the manner in which such methodologies and calculations have been made may have an impact on future rate revisions. As a result, the proposed order could directly affect Biomass One's future sales of power to PacifiCorp and its business operations.

5. Biomass One's intervention in this proceeding will assist the Commission in resolving the issues in this proceeding and will not unreasonably broaden the issues, burden the record, or unreasonably delay this proceeding.




