Purpose of the organization:

Southeast Uplift is a neighborhood coalition whose mission is to assist the citizens and neighborhood associations of Southeast Portland to create communities that are livable, socially diverse, safe and vital. Southeast Uplift provides an organizational structure and forum to empower citizens to effectively resolve issues of livability and community development. There are six staff and 20 board members. The organization represents 20 neighborhood associations and 11 business associations.

Petitioner's interest in the proceeding:

Southeast Uplift represents the interests of property owners, small businesses and non-profits who have interest in installing solar systems.

Issues petitioner intends to raise:

Southeast Uplift intends to monitor the proceedings and, if necessary, raise issues that are appropriate to the proceedings.
