III. Nature and Extent of Petitioner's Interest in This Proceeding

This docket has been opened to investigate the Oregon Universal Service Fund (“OUSF”). Verizon Competitive Providers are Competitive Telecommunications

Providers under ORS 759.005(1) authorized to provide a variety of intrastate telecommunications services in Oregon. These entities bill and collect OUSF surcharges from their customers for retail telecommunications services and remit those surcharges to the OUSF. 
