

Commission in resolving the issues in the proceeding:


Energy Trust can advise the Commission regarding delivery of its energy efficiency programs and the impact of current large customer funding limitations.



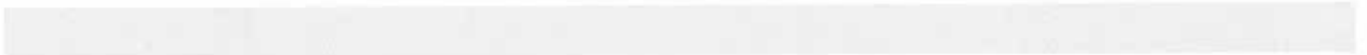
