The Oregon Department of Energy has statutory authority to promote efficient forms of transportation, including electric vehicles, under ORS 469.010 (2)(e): "energy-efficient modes of transportation for people and goods shall be encouraged, while energy-inefficient modes of transportation shall be discouraged." Utilities have been identified by the Legislature as having an important role in the increased adoption of electric vehicles in Oregon.


Additionally, the Department administers commercial programs for alternative vehicles and fueling infrastructure under ORS 469B.320, and residential alternative fueling infrastructure under ORS 469.160-469.180, both of which may be affected by the proceedings in this docket and companion dockets, UM 1812 and UM 1813.
