3. AWEC is an incorporated, non-profit association of large energy consumers in the Western United States, with offices in Portland, Oregon. A list of AWEC members is included as Attachment A. Many members of AWEC are customers of PacifiCorp (or the “Company”), as indicated on Attachment A.

4. On July 27, 2018, PacifiCorp filed its request to establish and maintain a balancing account to record the deferral of costs and revenues associated with the Company’s Transportation Electrification Program. If approved by the Commission, such a deferral will directly affect those of AWEC’s members who purchase power from PacifiCorp. AWEC therefore requests leave to intervene in this Docket to represent its members who are affected by any change to PacifiCorp’s rates.

5. AWEC represents the interests of a number of large customers served by PacifiCorp in Oregon. AWEC also has significant experience participating in proceedings before the Commission. AWEC’s intervention in this proceeding will assist the Commission in resolving the issues in this proceeding and will not unreasonably broaden the issues, burden the record, or unreasonably delay this proceeding.

6. As described above, AWEC has a direct and substantial interest in this proceeding that will not be adequately represented by any other party, and may be affected by

any Commission determination made in connection with this proceeding. It is in the public interest to allow AWEC to intervene in this proceeding.

WHEREFORE, AWEC respectfully requests that the Commission grant its petition to intervene with full party status in this proceeding.
