**Re: Annualized Billing Cycle Exception, OAR 860-039-0055(2)**

Pursuant to OAR 860-039-0055(2), PacifiCorp, dba Pacific Power, and Mr. Bill Muir, a net metering customer, have agreed to a new 12-month annualized billing period. OAR 860-039-0055(2) requires that the annual billing cycle for net metering customers end at the end of the March billing month each year, unless the utility and net metering customer agree to a different annual billing cycle. This section also requires the utility to notify the Public Utility Commission of Oregon within 30 days of a utility and a net metering customer reaching an agreement for a different annualized billing cycle. PacifiCorp and Mr. Bill Muir reached agreement for a new annualized billing cycle on September 19, 2012. The new annualized billing cycle for Mr. Wagner will end with the October billing period of each year.
