**SUPPLEMENT TO APPLICATION

I. INTRODUCTION

On July 27, 2018, PacifiCorp filed an application requesting an order authorizing the company to establish and maintain a balancing account to record the deferral of program costs and revenues related to PacifiCorp's Transportation Electrification Program (TE Program). PacifiCorp proposed to record in the balancing account the costs associated with the TE Program as described in the company's application filed per OAR 860-087-0030 and approved by the Commission in Order No. 18-075 in docket UM 1810.¹ In this supplemental filing, PacifiCorp has updated the anticipated costs for deferral to exclude capital costs.

III. DEFERRAL OF COSTS

A. Description of Utility Expense

PacifiCorp continues to propose to use deferred accounting to track the costs incurred under its TE Program and true up those costs using Schedule 95. PacifiCorp submits this supplemental application to clarify that it is proposing to only defer non-capital expenses.²

PacifiCorp incurred the following non-capital costs related to the TE Program, as agreed to by stipulating parties and approved by the Commission in UM 1810.


