On September 30, 2022, Idaho Power Company filed a petition for certificate of public convenience and necessity. The Public Utility Commission of Oregon (Commission) will hold a Public Comment Hearing on Idaho Power's request, as follows:

The Public Comment Hearing is an opportunity for customers and members of the public to offer unsworn testimony to the Commissioners and Administrative Law Judge. The event will begin with brief presentations from the Administrative Law Judge and Staff to explain the process. Because the purpose of this hearing is to take comments from the public, Idaho Power Company and the other parties to the proceeding will not make formal presentations and the Commissioners will not take questions. The Public Comment Hearing will be recorded and transcribed. The transcript will become part of the public comment record in the proceeding.
