The public comment hearing will convene at 6:00 p.m. and remain open until at least 7:00 p.m. If there are members of the public still waiting to offer comment at 7:00 p.m., the public comment hearing will continue until 8:00 p.m. to allow as many members of the public to comment possible. If we are unable to hear from everyone in the time available, we may conduct an additional public comment hearing at a later date.

The public comment hearing is an opportunity for customers and members of the public to offer unsworn testimony to the Commissioners and Administrative Law Judge. This event is being noticed as a Public Meeting because at least two Commissioners are planning to attend. The event will begin with brief presentations from the Administrative Law Judge and Staff to explain the rate case process. Because the purpose of this hearing is to take comments from the public, NW Natural, and the other parties to the proceeding will not make formal presentations and the Commissioners will not take questions. The public comment hearing will be recorded and transcribed. The transcript will become part of the public comment record in the proceeding. Spanish translation services are available for community convenience at no cost. Any comments received by the requested date of March 19, 2025, will be included in Staff's opening testimony. Any comments received by June 5, 2025, will be summarized and included in Staff's rebuttal testimony. Comments filed after June 5, 2025, will be posted to the comment section of the docket and reviewed, but will not be part of this docket's evidentiary record.
