PREHEARING CONFERENCE
MEMORANDUM

On February 20, 2020, the Public Utility Commission of Oregon held a prehearing conference in this docket. Representatives appeared on behalf of Idaho Power Company, STOP B2H Coalition, Sierra Club, Renewable Northwest, the Renewable Energy Coalition, and Commission Staff.

Petitions to Intervene

The Commission has received a petition to intervene from the Sierra Club. This proceeding is not a contested case under ORS 183.310(2) and will be conducted under the process set forth in OAR 860-027-0400. Persons need not intervene as a party in order to participate in this proceeding, and may attend workshops, submit written comments, and provide oral comments to the Commission at public comment meetings. Persons may seek party status, however, for the limited purposes of receiving copies of filings made by others and to be eligible to sign a protective order to obtain access to confidential information. Party status in this proceeding, however, does not confer the general rights and duties as those of parties in contested case proceedings. The petition to intervene filed by the Sierra Club is granted for the limited purposes described above.

Procedural Schedule

The parties jointly proposed a procedural schedule at the February 20, 2020 prehearing conference. The procedural schedule proposed by the parties did not include a date for a Commission Workshop between the dates for Staff and Intervenor initial comments, and Idaho Power reply comments. The parties' proposed procedural schedule is adopted with the addition of the date for a Commission Workshop, as follows:
