RULING

DISPOSITION: DEADLINES EXTENDED

On February 1, 2023, Sam Myers filed a motion to extend the deadline for amended opening testimony in this matter.¹ Although I would normally wait for parties to have an opportunity to respond to such a request, given the limited extension request here and the need for an expeditious decision, I am ruling on this motion without hearing from the other parties.

Mr. Myers requests a two-day extension to the deadline for his opening testimony to allow for the inclusion of “an email from the Morrow County Fire Authority.”² For good cause, I grant Mr. Myers’ request on the condition that only testimony related to the Morrow County Fire Authority be submitted by 3:00 p.m. on Friday, February 3, 2023. If necessary, Idaho Power may file any reply testimony responsive to this additional opening testimony from Mr. Myers by 3:00 pm. on February 24, 2023.
