RULING

**DISPOSITION: TESTIMONY AND EXHIBIT LIST AMENDED**

On May 10, 2023, I issued a ruling admitting testimony and exhibits in this docket and taking official notice of two documents. STOP B2H Coalition, Idaho Power, Wendy King, and John Williams submitted corrections to the evidentiary record listed in that ruling. Those corrections involved edits to the descriptions of items admitted to the evidentiary record and the withdrawal of an item included in the administrative record.

This ruling serves to correct the list of documents admitted to this matter’s evidentiary record and should be read alongside my May 8, 2023, and May 10, 2023, evidentiary record rulings in this docket.
