**MEMORANDUM REGARDING  
SCHEDULE FOR EVIDENTIARY  
HEARINGS**

The Commission will conduct evidentiary hearings in this proceeding on September 9, 10, and 11, 2020. The morning sessions will begin at 9:00 a.m. each day. In general, there will be a break of approximately fifteen minutes around the midpoint of each the morning and afternoon sessions. Additionally, I anticipate a break of approximately 45 minutes for lunch each day.

The witness schedule for evidentiary hearings is set forth below. Any witness not identified in the schedule below is not required at the evidentiary hearings, and will not receive an individual link to join the hearing as a panelist for the public sessions. These individuals may still access the public sessions of the hearings using the information included in the notice of evidentiary hearings issued September 4, 2020.<sup>1</sup>

Based on the parties' cross examination statements, the Commission will conduct separate sessions of the evidentiary hearing regarding confidential and highly confidential materials on Friday, September 11, 2020. PacifiCorp will be providing a secure Zoom platform for each of these sessions. Those individuals identified as active participants in the cross examination statements (including those who are not testifying) and qualified under the applicable protective order will receive an individual emailed link for accessing each session.

**Please note that this schedule is approximate and may shift based on the time needed for Commissioner questions, potential follow up cross examination from other parties, and any redirect.** To the extent we are ahead of schedule at the end of a morning session, we will likely begin with a witness scheduled for the afternoon session before breaking for lunch.
