RULING

DISPOSITION: TESTIMONY AND EXHIBITS ADMITTED; RECORD CLOSED

Portland General Electric Company; Staff of the Oregon Public Utility Commission; Oregon Citizens' Utility Board; Alliance of Western Energy Consumers; Verde; Charge Point, Inc.; and Walmart, Inc., filed motions to admit testimony and exhibits.
