RULING

DISPOSITION: STIPULATION, TESTIMONY, AND EXHIBITS ADMITTED;  
RECORD CLOSED

On March 28, 2025, Avista Corporation, dba Avista Utilities; Staff of the Oregon Public Utility Commission; Oregon Citizens’ Utility Board (CUB); the Alliance of Western Energy Consumers (AWEC); and joint environmental intervenors Climate Solutions/Green Energy Institute at Lewis & Clark Law School (collectively, the stipulating parties) filed a stipulation accompanied by a motion requesting the Commission approve the stipulation. On April 4, 2025, the stipulating parties filed a motion to admit the joint testimony and exhibits supporting the stipulation into the record of this proceeding, along with supporting declarations of Avista’s witness. Subsequently, individual parties filed separate motions to support previously filed testimony and exhibits, accompanied by declarations of their witnesses.

I find the testimony and exhibits offered by the parties and supported by the declaration of the witnesses meet the standards for relevance as required by OAR 860-001-0450(1) and satisfy the requirements of OAR 860-001-0480. No party opposed the admission of any testimony or exhibits.
