**SCHEDULING  
MEMORANDUM**

This memorandum proposes a draft procedural schedule for the utilities' recently filed resource value of solar (RVOS) filings. Parties should review this schedule and submit any requested changes to Staff, and Staff is directed to consolidate any requested changes and file a motion within one week of this memorandum. Staff may include any party workshop dates that it would like listed on the schedule in eDockets, and may list separate dates for the individual dockets if needed.

This memorandum is being served on parties to the UM 1716 RVOS policy docket, as well as the utility-specific RVOS calculation dockets, UM 1910 (PacifiCorp), UM 1911 (Idaho Power), and UM 1912 (PGE). These dockets are not consolidated, and parties should file petitions to intervene in each docket they wish to participate in, and file separate protective order signatory pages for the PacifiCorp and PGE dockets.


## Draft Procedural Schedule

Based on timelines discussed in Order No. 17-357 for utility specific proceedings, I propose the following procedural schedule:

Commissioner Workshop (parties select top two dates)	February 5 (am or pm) , 6 (am or pm) , 8 (am or pm) or 15 (p.m.)
Utilities Reply Testimony, All Party Cross-Answering Testimony	February 23, 2018
All Parties Cross-Examination Statements and Cross-Examination Exhibits	10 days before the hearing date
Hearing on RVOS Filings	March 22-23, 2018
Utilities Opening Briefs	April 6, 2018
Staff and Intervenor Response Briefs	April 20, 2018
Utilities Closing Briefs	May 4, 2018
Target Date for Decision	Late June, 2018
