SCHEDULING MEMORANDUM

On April 21, 2021, the Public Utility Commission of Oregon held a video scheduling conference in this docket. Representatives appeared on behalf of Avista Corporation, dba Avista Utilities, Commission Staff, the Oregon Citizens' Utility Board (CUB), and the Alliance of Western Energy Consumers (AWEC).

**Standard Protective Order**

Avista made an oral motion to enter a standard protective order in this docket. No party objected. I indicated that a standard protective order would be separately entered.

**Petition to Intervene**

AWEC filed a petition to intervene in this docket. Although a proceeding to review a utility's integrated resource plan (IRP) is not considered a contested case proceedings under ORS 183.310(2), the Commission grants petitions to intervene for the limited purposes of: 1) creating a service list; and 2) establishing eligibility to sign a protective order. The petition to intervene filed by AWEC is granted for the limited purposes described. In addition CUB filed its notice of intervention as allowed under ORS 774.180.
