PREHEARING CONFERENCE  
MEMORANDUM AND RULING

DISPOSITION: REQUEST FOR ADDITIONAL ROUNDS OF TESTIMONY AND  
HEARING GRANTED; PROCEDURAL SCHEDULE ADOPTED

On September 11, 2017, the Public Utility Commission of Oregon held a prehearing conference in this docket. Representatives appeared on behalf of PacifiCorp, dba Pacific Power; Commission Staff; ChargePoint, Inc.; Industrial Customers of Northwest Utilities; Oregon Citizens' Utility Board; Greenlots; and Forth.

**Opportunity to file Additional Testimony**

At the conference, a dispute arose as to the need for further evidence in this proceeding. The stipulating parties argued that no factual issues remain in dispute and believe that no additional rounds of testimony or hearing are needed to resolve this docket. ChargePoint responded that due process requires additional testimony, noting that it had not yet had the opportunity to file responsive testimony to the stipulation and the joint supporting testimony.

I find that additional evidence is required in this proceeding. Here, all parties other than ChargePoint have reached agreement and submitted a stipulation for Commission consideration. The stipulation, and testimony filed in support of that stipulation, will be received as evidence in the proceeding. *See* OAR 860-001-0350(7)(b). ChargePoint is correct that due process requires that it be afforded an opportunity to file responsive evidence to the stipulation and supporting testimony.
