Re: Docket No. PCN-5 – Idaho Power Company’s Notice of Petition for Certificate of Public Convenience and Necessity.

Attention Filing Center:

On September 1, 2022, Idaho Power Company (“Idaho Power” or “Company”) submitted to the Public Utility Commission of Oregon (“Commission”) a Notice of Intent to File a Petition for a Certificate of Public Convenience and Necessity (“CPCN”) for Construction of Overhead Transmission (“Petition”) authorizing construction of an approximately 300-mile long, overhead, 500-kV high voltage transmission line between the proposed Longhorn Station near Boardman, Oregon and the existing Hemingway Substation in southwest Idaho (“B2H project”). Idaho Power mailed that Notice of Intent to all landowners for which condemnation may be necessary, though we indicated condemnation is not our preferred path and we remain committed to negotiating fair compensation for landowners in exchange for easements and rights-of-entry to property along the B2H route.

Consistent with the representations in the Notice of Intent, on September 30, 2022, Idaho Power submitted to the Commission a Petition for a CPCN for Construction of the B2H project. Pursuant to the requirements of OAR 860-025-0030(2)(f), the Company is also mailing a copy of this notice to all landowners for which condemnation may be necessary informing them of Idaho Power’s submittal of this Petition.
