Avista Utilities (Avista) hereby provides notice that it anticipates designating information to be produced or used in this docket as protected under the Commission's General Protective Order, No. 23-132 (GPO). Avista anticipates that parties to this docket may request proprietary cost data and models, commercially sensitive load and resource projections, confidential market analyses and business projections, confidential employee data, and confidential information regarding contracts for the purchase or sale of natural gas. This confidential business information is of significant commercial value, which would expose the Company to competitive injury if disclosure is unrestricted.
